9. Concerns about the actions of Fernwood Parish Council

BS and PJ provided feedback on what proved to be a difficult Parish Council meeting regarding the FPC decision to disinvest a very significant sum from CCLA and hold cash. The key questions raised with the council were:

- i. Why such a substantial amount of money was disinvested against the advice of the outgoing clerk and in the absence of any firm projects requiring capital funding.
- **ii.** The abnormal procedure used to disinvest the funds, with no proposal on the published agenda and using Exempt Business on an unrelated subject to approve the disinvestment, when issues around finance should be in the public domain.
- iii. The implications for the year end audit of the council.

There was disappointment that FPC had decided to remove from their strategy the rights of freeholders on managed estates, which had been a long standing concern of previous Parish Councils and residents.

In response, IM on behalf of FPC stated the council position and that communication with NALC suggested that the council approach to the CCLA disinvestment was appropriate and followed procedure.

The discussion closed with BS thanking IM for his participation and input and that Parish Councillors are always welcome at FCRA meetings.
